## Re: Representative Lee Seok-ki Insurrection Conspiracy Case

## Dear President Park:

Greetings to you from The United Church of Canada, the largest Protestant denomination in Canada.

It was our privilege in September 2016 to welcome to Canada representatives of the "Korean Committee to Save the Victims of Representative Lee Seok-ki Insurrection Conspiracy Case". On behalf of The United Church of Canada, I am writing to express concern about this case.

We have become aware that in the fall of 2013, National Assembly Representative Lee Seok-ki and six other defendants – all members of the opposition Unified Progressive Party (UPP) – were arrested and charged on charges of insurrection conspiracy, conspiring to overthrow your government. Although the Supreme Court of Korea found the defendants not guilty of the charge of sedition conspiracy, it convicted Rep. Lee and colleagues on a charge of insurrection conspiracy based on remarks he made to political supporters and for which he has been sentenced to nine years in prison.

We write with concern that this case impedes your government's efforts to promote democracy and full human rights in Korea, peaceful freedom of expression, and ultimately reconciliation and peace on the Korean peninsula.

The United Church of Canada has been in long partnership with churches and other bodies in the Republic of Korea. The courageous faith of Korean Christians seeking peace with justice has deepened our church's own understanding of justice-seeking, expressed in active and peaceful involvement in society. We seek to support and amplify their efforts and those of many others in the Republic of Korea to bring a just resolution to the Representative Lee Seok-ki case.
